## PLANT AND EQUIPMENT HIRE

**Conditions of Hire** - All equipment is hired under CPA Model Conditions for the Hiring of Plant (with effect from July 2011), copies of which are available at the company office on request.

Customers attention is specifically drawn to the requirement to ensure that they arrange for adequate insurance for the equipment from the time of delivery until the time of collection. This cover should include loss by theft, fire or vandalism.

Customer's should ensure that they can provide suitably trained and experienced operators for the equipment that they are hiring.

**Payment Terms** - We shall be pleased to open a credit account on provision of satisfactory bank references, etc.

Our terms are strictly net - receipt of payment being required by the end of the month following date of invoice.

Interest may be due on invoices that have not been paid within the payment terms granted, at a rate of 10% per annum.

All hire rates exclude VAT which is an additional charge.

Proof of identification and a deposit may be required upon commencement of the hire, any such deposit paid shall not be refundable until then hirer has paid in full. The hirer shall not be entitled to any interest on the amount of the deposit for the period of time it is held by the owner.

We are able to accept payment by BACS, cheque, cash and credit card. Charges may apply when paying by credit card.

A minimum charge of £5.00 applies on all hires.

**Basis of Charging** - Minimum period of hire is one day. In many cases customers may wish to hire equipment for less than one week and frequently a weekly rate will be quoted by our branch staff. Should the period be less than one week the basis of charging will be:

1 day =	50% of weekly rate	4 days =	87.5%
2 days =	62.5% of weekly rate	5 days will be charged at the full weekly rate	
3 days =	75% of weekly rate		

Where a hire exceeds the week, additional days will be charged at 20% of the weekly rate (minimum periods excepted).

All plant is offered at a weekly rate and is based on a 5 day – 39 hour week.

All transport to and from site will be charged.

Fuel, re-sharpening and consumables items are extra and will be charged on completion of hire.

Charges will be made on equipment returned damaged or dirty - fair wear and tear excepted.

All damage to pneumatic tyres and punctures is the responsibility of the hirer. All site repairs must be carried out by the hirer at no cost, but to the satisfaction of the owner.
